

Dangerous Goods by Road Courses September 2011 to August 2012

Who needs to be trained?

Staff from road vehicle operators, shippers, freight agents, cargo handling agents and airlines who classify, pack, mark, or label dangerous goods which will be shipped by road; prepare transport documents; mark/placard vehicles, or are responsible for the provision of road transport vehicles, bulk packaging, or freight containers, and are directly involved in the transport of dangerous goods by road as determined by the competent authority.

What is a 'Top-up' course?

A 1-day course designed as an extension to our Dangerous Goods by Air (Certificate or Revalidation) course to provide the student with the additional knowledge required to deal with the requirements for sending dangerous goods by road.

Who is eligible for 'Top-up' training?

Any student who holds a current Dangerous Goods by Air certificate issued by TrainingTeam or, if this course is being used as refresher training, any student who has previously successfully completed a full Dangerous Goods by Road course. Certificates will be valid for 2 years.

Dangerous Goods by Road Refresher Training - £325 + vat

ADR Chapter 1.3, (1.3.2.4) also requires that "The training shall be periodically supplemented with refresher training to take account of changes in regulations." Holders of a valid DG by Road Certificate may attend the full 3-day course at a reduced rate. Alternatively, if you are a regular user of the ADR Regulations, you can attend the 1-day top-up course as refresher training. It is suggested that revalidation training should take place at approximately 2-yearly intervals.
